2. To confirm the enrolment, it is necessary to fill in the form on our website and make a bank transfer equal to at least the amount of accommodation as indicated on the website (if you are not staying at our facilities, the transfer must be equal to the fee of the "service to be added to the lesson package" of your choice and with the relative cost indicated on the site. INDICATE THE NAME AND SURNAME of the student + ACADEMY IN THE REASON FOR THE TRANSFER. It is necessary to send a copy of the transfer receipt by E-MAIL to: info@academysummerstage.it
3. By signing this deed I exempts the organization from any type of responsibility for any possible damage to person, object and building that I or any member of my family and guesses could may cost during the staying. The members and, if minors, those exercising the parental authority are also personally responsible for any damage caused to the host building, infrastructures or object. I, therefore, agree to take full responsibility, economically and legally in case of any occurrix accident and damage and I indemnifies cibi&ko ssl srl from any liability.
4. The organization is not liable for the loss, deterioration, damage or stolen object, values and personal effects of any participant or guess, as the organizers do not assume any custody obligation.
